4. At the time of joining duty the allotted candidates are directed to produce their original Educational Certificates to the Presiding Officers concerned for verification. If the certificates are already sent to the Tamil Nadu Public Service Commission, Chennai, they must produce the same after receipt from the Tamil Nadu Public Service Commission, Chennai. The Judicial Officers concerned are requested to report the fact of verification of the original certificates to this Court.
5. The appointment is made based on his / her claim made in his / her application for the said recruitment and that if any of his / her claim is found to be false, his / her selection and appointment will be cancelled without any further notice.

6. The Judicial Officers concerned are requested to intimate the date of joining duty of the concerned individual to this Court at once.
7. After joining of the candidate, the Judicial concerned are requested to ascertain from the candidate as to whether they have registered their name with any Employment Exchange. If so, the Judicial Officers concerned are requested to direct the candidates to surrender their Employment Exchange Identity Card and submit the same to this Court for further action.
