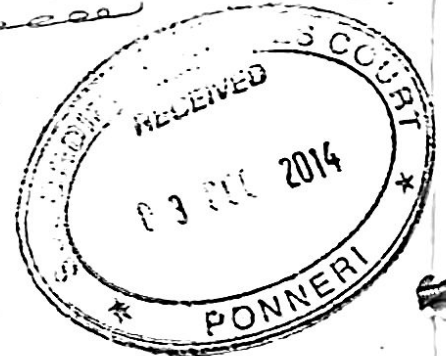
Sl.No.2 to 9 are hereby informed that they are entitled to draw subsequent increment, pay and allowances as per rules.
