### **ORDER:**

In the Government Order first read above, sanction was accorded among others to bring the certain temporary posts in the category of Junior Assistant, Steno-Typist Grade III, Store Keeper and Store Keeper-cum-Clerk which were sanctioned on consolidated pay / outsource basis in the Government Medical Colleges / Institutions viz. Kanniyakumari Government Medical College, Asaripallam, Tirunelveli Government Medical College, Tirunelveli, Thoothukudi Government Medical College, Thoothukudi, Vellore Government Medical College, Vellore and Government General Hospital, Chennai into regular time scale of pay from the date of issue of the order i.e. with effect from 01.04.2007, subject to fulfillment of



prescribed qualifications, rule of reservation etc., irrespective of the period of their service on consolidated pay.

2. In the Government Order second read above, sanction was accorded for regularizing the services of 166 candidates in the categories of Junior Assistant and Steno-Typist Grade III with effect from 01.04.2007 with seniority as mentioned in the Annexures to the said Government Order in the post of Junior Assistant and Steno-Typist Grade III respectively by relaxing rule 2 of the Special Rules for Tamil Nadu Ministerial Service and Regulation 17(3) of Tamil Nadu Public Service Commission Regulations, 1954, by invoking rule 48 of General rules for Tamil Nadu State and Subordinate Services.

3. The Director of Medical Education in his letter third read above has stated that Thiru.R.Sivaraman, Steno-Typist Grade-III, Office of Director of Medical Education, Chennai in his representation has requested for regularization of his temporary services in the post of Steno-Typist Grade-III with effect from 01.04.2007, i.e. from the date on which he was appointed into regular time scale of pay from consolidated pay. He has also stated that in G.O.(Ms).No.144, Health and Family Welfare Department, Dated 30.04.2007, Thiru.R.Sivaraman was brought into regular time scale of pay with effect from 01.04.2007 vide Proceedings No.2482/E4/2007, Dated 31.05.2007 of the Dean, Government Thoothukudi Medical College, Thoothukudi.

4. The Director of Medical Education has further stated that meanwhile, Thiru.R.Sivaraman was selected as Steno-Typist Grade-III by Tamil Nadu Public Service Commission and allotted to the Directorate of Medical Education, Chennai vide Directorate of Medical Education Ref.No.59509/E2/4/2007, Dated 06.09.2007 and he joined duty as Steno-Typist Grade-III at Directorate of Medical Education, Chennai on 10.09.2009 F.N. His temporary services were regularized with effect from 10.09.2009 F.N. He has declared to have completed the period of probation on 09.09.2011 A.N. Further, in G.O.(Ms.)No.218, Health and Family Welfare Department, Dated 09.09.2016, the temporary services in respect of 166 Junior Assistants and Steno Typists who were appointed on contract basis through Employment Exchange were regularized with effect from 01.04.2007. In that order, the name of Thiru.R.Sivaraman was inadvertently omitted, to be included in the proposal sent to the Government. He has requested to issue necessary orders on the request of Thiru.R.Sivaraman, Steno-Typist Grade-III, Directorate of Medical Education, Chennai to regularize his temporary services with effect from 01.04.2007 as was done for 166 candidates in G.O.Ms.No.218, Health and Family Welfare Department, Dated 09.09.2016.

5. The Government have again examined the issue in detail in the light of the views offered by the Tamil Nadu Public Service Commission and found that amongst, while regularizing the 166 candidates in the categories of Junior Assistant and Steno-typist Grade-III in the Government Medical Colleges / Institutions viz. Kanniyakumari Government Medical College, Asaripallam, Tirunelveli Government Medical College, Tirunelveli, Thoothukudi Government Medical College, Thoothukudi, Vellore Government Medical College, Vellore and Government General Hospital, Chennai, the name of Thiru.R.Sivaraman, Steno-Typist Grade-III, who was working at Thoothukudi Government Medical College, Thoothukudi, presently working at Directorate of Medical Education, Chennai was inadvertently omitted and not included in the proposal sent to the Government for regularization and hence, his



name was not included in the Government Order second read above. The Government has, therefore, decided to regularize the services of Thiru.R.Sivaraman, Steno-Typist Grade-III, Directorate of Medical Education, Chennai in the categories of Steno-Typist Grade III with effect from 01.04.2007 by relaxing rule 2 of the Special Rules for Tamil Nadu Ministerial Service and regulation 17(3) of Tamil Nadu Public Service Commission Regulations, 1954, by invoking Section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act, 14 of 2016) in favour of the said individual as was done to 166 candidates in the Government Order second read above.

6. Accordingly, the Government do and hereby direct that the services of Thiru.R.Sivaraman, Steno-Typist Grade-III, Directorate of Medical Education, Chennai in the post of Steno-Typist Grade-III be regularized with effect from 01.04.2007 by relaxing rule 2 of the Special Rules for Tamil Nadu Ministerial Service and regulation 17(3) of Tamil Nadu Public Service Commission Regulations, 1954.

7. In exercise of the powers conferred under Section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act, 14 of 2016), the Governor of Tamil Nadu hereby relaxes rule 2 of Special Rules for Tamil Nadu Ministerial Service and regulation 17(3) of Tamil Nadu Public Service Commission Regulations, 1954 in favour of Thiru.R.Sivaraman, Steno-Typist Grade-III who have appointed as Steno-Typist Grade-III in Thoothukudi Government Medical College, Thoothukudi, presently working at Directorate of Medical Education, Chennai, so as to regularize his services in the categories of Steno-typist Grade III with effect from 01.04.2007.
