

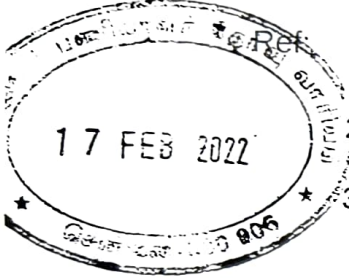

ORDER:

She has joined duty in the post of Junior Assistant on the Forenoon of 14.08.2020 at Office of the Medical Services Recruitment Board, Chennai-6. She is fully qualified to hold the said post.

The Tamilnadu Public Service Commission in their letter reference 1st cited has issued necessary concurrence for regularisation of the services of the selected candidates. Accordingly the temporary Services of Tmt.P.Vinithra, Junior Assistant, Medical Services Recruitment Board, Chennai-6 is regularized in the post of Junior Assistant with effect from the date of joining duty in the post of Junior Assistant i.e. from 14.08.2020 Forenoon, subject to the following condition.

“ The regularization is subject to the outcome of the W.Ps pending on the files of the Honourable High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination IV for the year 2018- 2019 and 2019-2020 ”.
