the individual, as mentioned below:

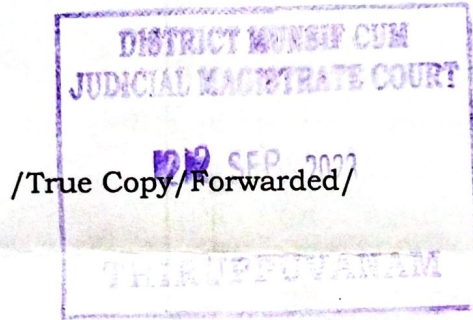
