ORDER:

Tmt.S. Selvi, had been selected in Group - IV services competitive examination for 2013-2014 conducted by the Tamilnadu Public Service Commission, and allotted to the Department of Medical and Rural Health Services as per the reference 1<sup>st</sup> cited. As per reference 2<sup>nd</sup> cited, she was temporarily appointed as Typist under Rule 10a(i) of the Tamil Nadu State and Subordinate Services in the pay band of Rs.5200 - 20200 + GP Rs.2400 and posted to the Medical Officer, Government Leprosy Treatment and Study Centre, Aragandanallur. She had joined duty as typist on the F.N. of 23.09.2014. She is fully qualified to hold the post of Typist.

As per the instructions contained in the letter reference 1<sup>st</sup> cited, the temporary services of Tmt.S. Selvi, Typist, Government Leprosy Treatment and Study Centre, Aragandanallur, are regularised in the post of Typist with effect from the date of Joining duty in the post of Typist, i.e. from 23.09.2014 FN, subject to the following condition:-

"The regularisation is subject to final outcome of the WPs/Cases before the Honourable High Court, Madras and Madurai Bench of Madras High Court related to this recruitment".

She is placed on probation for a period of two years within the continuous period of three years from the date of regularisation.

2. Computer on Office Automation Examination.
