

Hence, till the completion of such foundational course training at Bhavanisagar, the probation period of concerned Junior Assistants who are appointed by Direct Recruitment is extended as per rule 31 of Special Rules for TNJMS till they have to undergo the required training.
		The concerned Presiding Officers are required to take necessary steps for declaration of probation of staff concerned and completion of satisfaction of service of two years on duty from the above said date of regularization within a period of 3 years orders passed in this regard is required to be submitted to this Court for approval along with Service Register of the concerned individual.
