**ORDER:-**

Thiru M.Dominic Rajkumar, Junior Assistant was initially appointed as Data Entry Operator in the O/o the Superintendent of Police, Virudhunagar District, under compassionate grounds 1<sup>st</sup> read above. He reported for duty, as Data Entry Operator on 13.12.2010 FN.

2. His service as Data Entry Operator has been regularized with effect from 13.12.2010 FN. and probation declared with effect from 21.12.2012 AN, 2<sup>nd</sup> and 3<sup>rd</sup> read above.

3. He was appointed as Junior Assistant 4<sup>th</sup> and 5<sup>th</sup> read above and posted to Chief Office. He was reported for duty on transfer of service in this office, as Junior Assistant on 11.08.2018 FN. and he was transferred to Greater Chennai Police, Chennai on 18.03.2019.

As per Chief Office circular memo 7<sup>th</sup> read above the post of Junior Assistant may be regularized as per the G.O.Ms.No.80, Labour and Employment (Q1) Department dated 02.03.2016, as the post of Data Entry Operator comes under Tamil Nadu General Subordinate Service and the post of Junior Assistant comes under Tamil Nadu Ministerial Service.

5. As per the G.O.Ms.No.80, Labour and Employment (Q1) Department dated 02.03.2016, the post of Junior Assistant / Typist can be regularized by the appointing authority concerned.

6. Therefore, Thiru M.Dominic Rajkumar, Junior Assistant, Chief Office has fully satisfied all the terms and conditions relevant to the appointment on Compassionate Grounds. Hence it is hereby ordered that his services are regularized with effect from 11.08.2018 FN. (i.e) from the date of appointment on transfer of service, as Junior Assistant.
