In this office proceedings 2nd cited above, orders have been issued to the candidates selected by the Tamil Nadu Public Service Commission vide reference 1st cited above by appointing them as Direct Assistant in the Animal Husbandry Department.

The services of the Direct Assistants listed in the annexure to this order are regularised with effect from the date mentioned in column No.4 against each.

The regularisation is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to Combined Civil Services Examination - II, Group - IIA Services for the year 2017-18 recruitment.

The order of seniority of the Direct Assistant, listed in the annexure will be issued separately on receipt of the same from the Tamil Nadu Public Service Commission.

The Direct Assistants whose services have been regularized are placed on probation for a period of two years within a continuous period of three years from the date of regularization.

The probation will be declared in their cases only after passing the following tests within the period of probation:-

- a) should complete the Fundamental Training for a period of two months at Civil Services Training Institute, Bhavanisagar; and
- b) should pass the following tests, namely:-
 - i) Account Test for Subordinate Officers, Part - I and
 - ii) Departmental test in the Manual of the Animal Husbandry Department

Arrears of increment shall be allowed from the date of completion of probation as per rules.

If any charges are pending against the individuals mentioned in column No.2 in the annexure to this order, this order should not be served to them and the same should be intimated to this office immediately.

The Regional Joint Directors of Animal Husbandry concerned are requested to acknowledge the receipt of this order and necessary entries regarding the regularization of the services of the Direct Assistants should be made in the Service Register of the individuals concerned. In case, any Direct Assistants have been transferred to other region, this order should be sent to them through the Regional Joint Directors of Animal Husbandry concerned without fail.






