- 3. "The regularization is subject to the outcome of WP's (if any) pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Hon'ble High court of Madras relating to Group-II A 2017-2018 recruitment."
- 4. They shall be allowed first increment on completion of duty period of one year in their service. The second and subsequent increments will be sanctioned only on satisfactory completion of probation.
