The above individuals are placed on probation for a period of 2 years on duty within a continuous period of 3 years from the dates of their regularisation subject to the following conditions as required in the Tamil Nadu Government Servants (Conditions of Service Act, 2016) to complete their probation.
 - i) They should pass the Tamil Nadu Government Office Manual Test conducted by the Tamil Nadu Public Service Commission.
 - ii) They should pass the Account Test for Subordinate Officers Part I conducted by the Tamil Nadu Public Service Commission.
 - iii) They should successfully complete the two months Foundational Training at Civil Service Training Institute, Bhavanisagar.
- 3. The regularization is subject to the outcome of WP's (if any) pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High court of Madras relating to Group-II A 2014-2015 and 2015-2016 recruitment.
- 4. They shall be allowed first increment on completion of duty period of one year. The second and subsequent increments will be sanctioned only on satisfactorily completion of probation.
- 5. Orders fixing seniority will be issued separately.
