The above individual has to complete the Certificate course in Computer on Office Automation within the prescribed period of probation or within two years from the date of appointment to the post as the case may be vide G.O.Ms.No.130 P and AR (S) Department Dated.22.07.2008 and also as per Annexure V referred to in Rule 34 of Tamilnadu Ministerial Service the above individuals has to complete the test of Tamilnadu Government Office Manual within their prescribed period of probation, otherwise, they may be dealt as per the provision under General Rule 27 of Tamilnadu State and Subordinate Service.
