ORDER:

Selvi.S.Madhumadhi was given provisional and conditional selection by Tamil Nadu Public Service Commission on conduct of written examination for Direct Recruitment to the post of Junior Assistants included in Combined Civil Services Examination - IV [Group IV - Date of examination 24.07.2022] vide the reference 1st cited subject to verification of her PSTM (Persons Studied in Tamil Medium) claim. The individual was referred for postings in Coimbatore Intelligence Wing vide the reference 2nd cited and appointment orders were issued to the individual vide this office proceedings in the reference 3rd cited.

Accordingly, the individual joined as B3, Junior Assistant, Office of the Joint Commissioner(ST), Intelligence, Coimbatore on the Forenoon of 08.09.2023. The individual's PSTM Claim is found to be genuine as per the report

of the Joint Director, Directorate of School Education, Chennai in the reference 4th cited. Therefore, the service of the individual is hereby regularized and commencement of probation is ordered from the date of joining of her duty i.e., from FN of 08.09.2023.

The individual has to complete her period of probation of **two years** satisfactorily with a continuous period of three years and she has to pass the Department examination, namely, Tamilnadu Government Office Manual Test and has to undergo the Bhavani Sagar Foundational Course Training in the said period.
