ORDER:

Tr.R.Jhon Raj Kumar, S/o. Late Robert (Gr-I PC/6982/Chennai)
was appointed as Data Entry Operator and he joined the Chennai City Police
on compassionate grounds on 07.11.2005 as per the reference 1stcited.
subsequently he was fit for appointed as Junior Assistant by transfer of service for
the year 2018-2019 his temporary appointed as Junior Assistant and posted to SBCID
Chennai vide Chief Office reference 2nd cited. He reported duty on 01.10.2018 FN.

2.In the G.O. Ms.No.220 Home (Pol.XV) Dept dt:18.02.2016 adhoc
rules have been framed in respect of Data Entry Operators and it has been ordered that
the rules are to be implemented with retrospective date i.e 01.05.2007 FN.As per
instruction in Chief Office memo 3rd cited, the service of Tr.R.Jhon Raj Kumar, in the post
of Data Entry Operator was regularized with effect from 01.05.2007 and his probation in

that post was also declared on 30.04.2009AN in the NZO.No.392/2016 dated 30.06.2016 of the Joint Commissioner of Police, North Zone, Greater Chennai Police referred in the reference 5th cited.

3. Further, in the G.O.Ms.No.80 L&E (Q.1) Dept., dated 02.03.2016 communicated in Chief Office memo in C.No. 041769/CAR.1/2016, instructions have been issued regarding regularization of service of those who were appointed before 01.02.2016 on compassionate grounds . As per the guidelines in para 6.1 & 6.2 of the said G.O. the appointing authority can issue Orders on regularization service if no relaxation of rules/ exemption of Government orders was required. Tr.R.Jhon Raj Kumar was appointed as Data Entry Operator without any relaxation of rules regarding submission of petition within 3 years period and eligible educational qualification at the time of submission of petition.

4. As per the guidelines in para 6.1 & 6.2 of G.O. 80 L&E (Q.1) Dept., dated 02.03.2016 the service of Tr.R.Jhon Raj Kumar , who was appointed as Junior Assistant on compassionate grounds and reported on 01.10.2018 FN without relaxation of rules/ exemption of Government orders is regularized in the post of Junior Assistant w.e.f 01.10.2018 FN i.e the date of his joining as Junior Assistant.
