

**REGULARISATION OF SERVICE AS JUNIOR ASSISTANT - ORDERED**

In the Chief Office orders in C.No.130052/NGB 2(2)/2016, dated 26.10.2017 and C.No.084761/NGB 2(2)/2018, dated 02.08.2018 orders were issued for appointment of the following Data Entry Operators as Junior Assistants by transfer of service and posted to TSP III Battalion, Veerapuram, Chennai. Accordingly, they were appointed as Junior Assistants and reported in this office on the dates noted against each.

2) In the Chief Office circular memorandum in C.No.041769/CAR.1/2016, dated 21.12.2017, instructions were issued for regularization of services of those who were appointed as Junior Assistants/Typists from the post of Data Entry Operators, as follows:

"For regularizing the service of those who were appointed from one sub-ordinate service to another sub-ordinate service, the concurrence of the TNPSC is not necessary. The post of Data Entry Operator is listed under the Tamil Nadu General Sub-Ordinate services, whereas the post of Junior Assistant/Typist were listed under the Tamil Nadu Ministerial Services. However, considering the pay scale of the posts of JA /Typist, it is construed that these posts come under the sub-ordinate services. Hence, the concurrence of the TNPSC is not necessary for regularizing the services of those who were appointed as Junior Assistant/Typist from the post of Data Entry Operator".

The above rules are applicable for those who were initially appointed as Data Entry Operator on compassionate grounds and later on appointed as Junior Assistants/Typist from the post of Data Entry Operator. Their services may be regularized by the appointing authority itself and the fact may be intimated to Chief Office, Chennai.

3) In pursuance of the above said Chief Office instructions, the services of above 02 Junior Assistant, who were appointed as Junior Assistant from the post of Data Entry Operator are regularized with effect from their date of appointment as Junior Assistant i.e., 16.11.2017 FN and 20.08.2018 FN respectively.
