In the Chief Office circular memorandum in C.No. 041769/AR.1/2016 dated 21.12.2017, instructions were issued for the regularization of services of those who were appointed as Junior Assistant from the post of Data Entry Operator, as follows:

"For regularizing the service of those who were appointed from one sub-ordinate service to another sub-ordinate service, the concurrence of the TNPSC is not necessary. The post of Data Entry Operator is listed under the Tamil Nadu General Sub-ordinate services, where as the post of Junior Assistant/Typist were listed under the Tamil Nadu Ministerial Services. However, considering the pay scale of the post of Junior Assistant/Typist, it is constructed that these posts comes under the Sub-ordinate services.
