REGULARIZATION ORDERS ISSUED

Selvi/Tmt. R. Savithiri, (Reg. No.06310055) was selected through Tamil Nadu Public Service Commission provisionally for the post of Junior Assistant included in Group-IV Service Examinations for the year 2007-2008 to 2012-2013 and allotted to the Police Department conditionally subject to verification of the Community claim as Scheduled Tribe - Hindu -Uraly by the State Level Scrutiny Committee.

2] As per Chief Office Memorandum in C.No. 009184/NGB II (2)/2012, dated 18.01.2013, Selvi/Tmt. R. Savithiri, Range Office, Salem had been appointed as Junior Assistant through TNPSC and reported for duty on 08.02.2013FN in the Office of the Dy. Inspector General of Police, Salem Range, Salem, vide this office order in R.O.No. 23/2013, Rc.No.A2/0522/2013, dated 24.01.2013. Her Community Certificate Genuineness (Scheduled Tribe - Hindu- Uraly) had been under verification by the Tamil Nadu State Level Scrutiny Committee-III of Adi Dravidar and Tribal Welfare Department, Secretariat, Chennai.

3] The Tamil Nadu State Level Scrutiny Committee-III of Adi Dravidar and Tribal Welfare Department, Secretariat, Chennai in their Proceedings in C.No. 12431/CV-4(2)/2013-11, dated 03.12.2021 has been ordered that the "Hindu-Uraly" Scheduled Tribe Community Certificate No. 4457418 issued to the individual by the Revenue Divisional Officer, Gobichettipalayam, Erode District, vide Ref 7744/2001/35/2001, dated 23.07.2001 is correct.

4] Now, the Secretary, TNPSC in their letter No. 5949/PSD-G1/2013, dated 16.6.2022 has been stated that, conditional appointment in respect of Selvi/Tmt. R. Savithiri, Junior Assistant has now been finalized and it has been stated that the temporary services of above Junior Assistant may be regularized from the date of her joining duty in Police Department as Junior Assistant, if she is otherwise eligible and Chief Office in their memorandum in Rc.No. 118996/NGB II(2)/2013, dated 04.07.2022 has been instructed to regularize the service of Selvi/Tmt. R. Savithiri in the post of Junior Assistant from the date of her joining, if she is otherwise eligible.

5] Accordingly, the temporary services of Selvi/Tmt. R. Savithiri in the post of Junior Assistant from the date of her joining duty in Police Department on 08.02.2013 FN are regularized.
