REGULARIZATION OF SERVICE AS TYPIST - ORDERED

Tr.T.Prakash, Data Entry Operator, District Police Office, Coimbatore whose name was included in the panel of Data Entry Operators fit for appointment as Typists by transfer of service for the year 2019-2020 was temporarily appointed as Typist and posted to TSP IV Battalion, Kovaipudur in Chief office appointment order in C.No.159985/NGB 2(2)/2019, dated 20.09.2019. He has reported for duty in this Battalion on 01.10.2019 FN.

2) In the Chief office circular memorandum in C.No. 041769/AR.1/2016, Dated: 21.12.2017, instructions were issued for the regularization of services of those who were appointed as Junior Assistant/ Typist by transfer of Service from the post of Data Entry Operators, as follows:

“For regularizing the service of those who were appointed from one sub - ordinate service to another sub - ordinate service, the concurrence of the TNPSC is not necessary. The post of Data Entry Operator is listed under the Tamilnadu General sub - ordinate services. Where as the post of Junior Assistant / Typist were listed under the Tamilnadu Ministerial Services. However, considering the pay scale of the posts of Junior Assistants / Typists, it is construed that these posts comes under the sub - ordinate services of those who were appointed as Junior Assistant / Typists from the post of Data Entry Operator.”

3) The above rules are applicable for those who were initially appointed as Data Entry Operator on Compassionate grounds and later appointed as Junior Assistant / Typist from the post of Data Entry Operator. Their service may be regularized by the appointing authority itself and the fact may be intimated to Chief office, Chennai.

4) Accordingly in pursuance of the above said Chief office instructions, the services of the above Typist, who was appointed as Typists from the post of Data Entry Operator, are regularized with effect from their date of appointment i.e., on 01.10.2019 FN as Typist.
