REGULARIZATION OF SERVICE AS JUNIOR ASSISTANT – ORDERS ISSUED

Ref: Chief office Appointment Order in
RC.No.3756001/NGB.II(2)/2022-8, dated.02.05.2023.

In accordance orders issued in the reference cited above, the following Junior Assistant was appointed as Junior Assistant by transfer of service from DEOs and posted to the places as noted against him.

2) In the Chief Office circular memorandum in C.No.041769/CAR.1/2016, dated.21.12.2017, instructions were issued for the regularization of services who were appointed as Junior Assistant form the post of Data Entry Operators, as follows:

“For regularizing the service of those who were appointed from one sub-ordinate service to another sub-ordinate service, the concurrence of the TNPSC is not necessary. The post of Data Entry Operator is listed under the Tamil Nadu General Sub-ordinate services, Where as the post of Junior Assistant / Typist were listed under the Tamil Nadu Ministerial Services. However, considering the pay scale of the post of Junior Assistant / Typist, it is construed that these posts comes under the Sub-ordinate services. Hence, the concurrence of the TNPSC is not necessary for regularizing the service of those who were appointed as Junior Assistant / Typist from the post of Data Entry Operator.”

3) In accordance with the Government letter No.75466/Police.XV/2021-2, dated: 10.11.2023 and Chief Office memo in C.No.797992/CAR/2023, Dated: 07.12.2023, the service of Junior Assistant who are appointed on transfer of service from Data Entry Operator shall be regularized by the appointing authority while no rule relaxation is involved.

4) In this connection, there is no rule relaxation is needed to regularize the services of the above Junior Assistants.

5) Hence, in accordance with the above said Chief Office instructions, the services of the above Junior Assistant is regularized with effect from the date of his joining as Junior Assistant.
