ORDER:

2. The above individual's regularization is subject to the final outcome of the Writ petition relating to Group- IV for the 2015-16, 2016-17 and 2017-18 recruitment pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court.

3. The above individual shall be on probation for a total period of two years on duty within a continuous period of three years vide rule 32 (a) (i) of Tamilnadu Ministerial service rules.

4. As per Annexure V referred to in Rule 34 of Tamilnadu Ministerial Service the above individual has to complete the test of Tamilnadu Government Office Manual within their prescribed period of probation, otherwise, they may be dealt as per the provision under General Rule 27 of Tamilnadu State and Subordinate Service.
