- 2. As per rule 37 of Special rule TNJMS, a person who is appointed as Junior Assistant by Direct Recruitment has to undergo the foundational course training at Bhavanisagar within the period of his Probation without such regularisation of service, they are not eligible to undergo such training. Hence, till the completion of such foundational course training at Bhavanisagar, the probation period of concerned Junior Assistants who are appointed by Direct Recruitment is extended as per rule 31 of Special Rules for TNJMS till they have to undergo the required training.
- 4. The concerned Presiding Officers are required to take necessary steps for declaration of probation of staff concerned and completion of satisfaction of service of two years on duty from the above said date of regularization within a period of 3 years orders passed in this regard is required to be submitted to this Court for approval along with Service Register of the concerned individual.
- The receipt of service register of the individuals are to be acknowledged at once.
