3] They are placed on probation for a period of two years on duty within a continuous period of three years. During this period, they should pass the Tamil Nadu Government Office Manual Test.

4] They are also informed that they should acquire the Certificate Course in Computer on " office automation " awarded by the Directorate of Technical Education in addition to the Technical Educational Qualification for the post of Typist. Those who possess Degree [or] Diploma in Computer Science [or] Computer Engineers as one of the subject approved by the University Grant Commission/ All India Council for Technical Education/ Directorate of Technical Education [or] an equivalent body are exempted from passing the " Certificate Course in Computer on office Automation " conducted by the Directorate of Technical Education.
