The individuals noted in Sl.No.1, 8, 9, 13 and 19, are informed that their selection are purely provisional and **CONDITIONAL** subject to verification and acceptance of the PSTM (Persons Studied in Tamil Medium) certificate from the competent authority viz., the Director of School Education and their temporary services will not be regularized in the post of Junior Assistant until their PSTM claim is accepted by this department, based on receipt of genuineness report from the Director of School Education.

The aforesaid individuals are further informed that **regularization of their services are subject to the outcome of the WP's pending on the files of the Hon'ble High Court, Madras / Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination - IV (Group -IV Services).**

The aforesaid individuals are further directed to produce a **certificate of Physical Fitness**, obtained from a Medical Officer not lower than the rank of Civil Surgeon, at the time of joining duty.

The Presiding Officers of the court concerned are required to administer the oath of allegiance to the aforesaid individuals at the time of joining duty.

After the above said individuals having joined duty, the Presiding Officers of the Court concerned are required to ascertain from the individuals whether they have registered their names with any employment exchange. If so, the individuals shall be asked to surrender their employment exchange identity card, and the same should be submitted to this court, so that the registration of the concerned candidates will be removed from the Live Register of Employment Exchange.

The report regarding the Joining of the aforesaid individuals should be intimated to this court, immediately.
