 - (a) Complete the Foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar.
6. She is also informed that the appointment is temporary and selection is made based on her claim made in her application for the said recruitment and that if any of her claim is found to be false, her selection and appointment will be cancelled without any further notice.
