In accordance with the allotment order issued by the Addl. Director General of Police (Admin), O/o Director General of Police/HoPF, Tamil Nadu, Chennai and the appointment order issued by the Deputy Inspector General of Police, Training, Police Training Headquarters, Chennai vide reference 1st& 2nd cited, Tr.T.Kaleapraj, (TNPSC Registration No.1004033159) who selected from TNPSC Recruitment (Direct) included in Combined Civil Services Examination IV(Group IV Services - 07/2022) to the post of Junior Assistant had joined at Police Training School, Thiruvallur in the post of Junior Assistant on 27.10.2023 F.N.

2) After verification of all the educational certificate and community certificate of Tr.T.Kaleapraj, Junior Assistant, it is found that all the certificates produced by him at the time of appointment are genuine, as per the genuineness letter received by the authority concerned.
