- 4. The above individuals are hereby instructed to report for duty to their respective Office on or after 26.11.2018 but before 10.12.2018 (Excepting Saturday and Sunday being Government holidays)
- 5. The appointment of the individuals is on regular basis since their applications have been admitted finally by the Commission. The above individuals are hereby informed that their regularization of services is subject to the outcome of the WPs (if any) pending on the files of the Hon'ble High Court of Madras/Madural Bench of the Hon'ble High Court of Madras relating to Group IIA Services/2017-2018 recruitment.
- 6. The above individuals are hereby placed on probation for a total period of two years on duty within a continuous period of three years. On completion of two years of probation period, the head office shall intimate the same to this Directorate for declaration of successful completion of probation by Dy Director General NCC, subject to the condition that they adquire the other required qualifications during the above period.
- The above individuals shall within the period of probation:-
 - (a) Complete the Foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar, and
 - (b) Pass the following tests, namely: -
 - (1) Account Test for Subordinate Officers, Part-I,
 - Departmental Test conducted by the Deputy Director General, National Cadet Corps.

The above named individuals are informed further that:-

- (a) They should produce the physical fitness certificate from the Civil Assistant Surgeon in the form prescribed vide FR 10 as amended from time to time including G.O.Ms.No.702 P&AR dated 08 Jul 85. They are requested to obtain a physical fitness certificate in the attached format from not lower than an Assistant Civil Surgeon. (In case of physically handicapped candidate, they should obtain necessary medical board certificate from the Special Employment Exchange for Physically Handicapped in terms of G.O.Ms.No.733 Social Welfare Department dated 09 Oct 1980).
- (b) Their appointment is liable for termination if they are found to be physically not fit.
- (c) They will be governed by various rules and regulations and directions/instructions issued and amended from time to time as applicable to a State Government Servant of Tamil Nadu. Few Codes and Manuals, rules etc are noted hereunder:-

- 9. They are informed that in case if they fail to join duty before specified date, the same will be reported to the Secretary, Tamil Nadu Public Service Commission, Chennal -3 for removal of their name from the approved list of candidates for appointment.
- 10. They are informed that no representation regarding joining time will be entertained and that failure in joining duty within specific date and place will result in their name for removal from the approved list.
- 11. The Head of Office is required to ascertain from the individual as to whether he/she has registered his/her name with any employment exchange. If so, he/she may be asked to surrender his/her employment exchange identity card, and the same may be sent by the Head of Office either to the District employment exchange where the candidate has registered his/her name or to the Director of Employment and Training, Chennal, so that the registration of the concerned candidate(s) may be removed from the Live Register of Employment Exchange. This shall be done under intimation to the Directorate/TNPSC.

- 12. The candidates are hereby informed that they will have to serve in the office to which they are hereby posted for a minimum period of two years from the date of their appointment. They are also informed that they are liable for transfer once in three years to any of the stations in Tamil Nadu.
