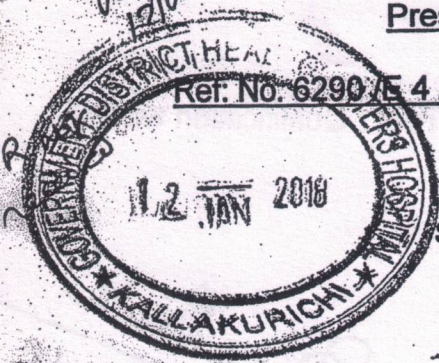

**ORDER:**

Thiru.V.Veerapathiran had been selected in Group IV services competitive examination for 2013-2014 and 2014-2015 conducted by the Tamil Nadu Public Service Commission and allotted to the Department of Medical and Rural Health Services as per the reference 1<sup>st</sup> cited. As per reference 2<sup>nd</sup> cited, he was temporarily appointed as Typist under Rule 10 a (1) of the Tamil Nadu State and Subordinate Services in the pay Band of Rs.5200 - 20200 + GP Rs. 2400 and posted to Government District Head Quarters Hospital, Kallakurichi, Villupuram District. He had joined duty as Typist on the F.N. of 07.11.2016. He is fully qualified to hold the post of Typist.

As per the instructions contained in the letter reference 1<sup>st</sup> cited, the temporary services of Thiru.V.Veerapathiran, Typist Government District Head Quarters Hospital, Kallakurichi, Villupuram District are regularized in the post of Typist with effect from the date of Joining duty in the post of Typist, i.e. from 07.11.2016 FN, subject to the following condition.

He is placed on probation for a period of two years within the continuous period of three years from the date of regularization.
