Deebika was selected provisionally by Tamil Nadu Public Service Commission for appointment by recruitment to the post of Junior Assistant included in Group-IV (Date of Examination 24.07.2022) and as per the Proceedings of the Joint Commissioner (ST), Virudhunagar in the reference 2nd cited, the individual was appointed as Junior Assistant in the office of The Appellate Deputy Commissioner (ST), Virudhunagar and posted as Junior Assistant in this intelligence division vide the reference 4th cited. In continuation of her appointment, the individual services are hereby ordered to be regularized in the cadre of Junior Assistant from the date as noted against them as under:

Probation is also commenced from the date of regularization as noted above.

2. The above individual regularization is subject to the final outcome of the Writ petition pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Group-IV services 2022 recruitment.

3. The above individual shall be on probation for a total period of two years on duty within a continuous period of three years vide rule 32 (a) (i) of Tamil Nadu Ministerial service rules.

4. As per Annexure V referred to in Rule 34 of Tamil Nadu Ministerial Service the above individual has to complete the following tests and training within their prescribed period of probation, otherwise, they may be dealt as per the provision under General Rule 27 of Tamil Nadu State and Subordinate Service.

- a. To Complete the Foundation Training for a period of two months at Civil Services Training Institute, Bhavanisagar. The training period shall be allowed to count for increment and probation.
- b. To Pass the Departmental Tests, namely :
