The temporary service of the individual is regularized w.e.f. 23.09.2020 F.N. i.e., from the date of joining duty of the individual subject to the following conditions:-

- 1) Thiru.S.Elavarasan, Junior Assistant, ESI Dispensary, Gummidipoondi whose temporary services is regularized in this order is placed on probation for a period of two years within the continuous period of three years from the date of regularization.
