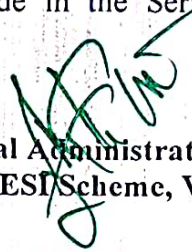
The regularization is subject to the outcome of Writ petitions if any pending at the Hon'ble High Court of Madras/ Madurai Bench
