PLACING ON PROBATION:

5. The above individual is placed on probation for a total period of two years on duty within a continuous period of three years, with effect from **01 Aug 2024(FN)**. Orders on declaration on probation of the individual will be issued by this Directorate on completion of probation period by the individual and subject to the condition that he acquires the other required qualifications during the above period.
