(i) The regularisation is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in combined Civil Services Examination - IV (Group-IV).

(ii) The Candidates who do not possess "Adequate Knowledge in Tamil" should pass II Class language test (full test) in Tamil within the period of probation as per the Section 21(1) of Tamil Nadu Government Servants (Conditions of Service) Act 2016.

The individuals are placed under Probation for a period of two years on duty within a continuous period of three years from the date of the Regularization.

Further, the Head Ministerial staff of the concerned Courts are instructed to make necessary entries in the respective Service Register of the individual in this regard without fail.
