ORDER:

Tmt.R.Saroja, Under Secretary in the Office of Tamil Nadu Public Service Commission expired while in service on 19.11.2015 leaving his family in indigent circumstances. The Secretary, Tamil Nadu Public Service Commission vide Proceedings first read above, has appointed Thiru. R.Ganesh, S/o late Tmt.R.Saroja, former Under Secretary, Tamil Nadu Public Service Commission as Assistant in the Office of the Tamil Nadu Public Service Commission on compassionate grounds.

2. In the letter 4th read above, the Secretary, Tamil Nadu Public Service Commission has requested the Government to regularise the services of Thiru.R.Ganesh, S/o late Tmt.R.Saroja, appointed as Assistant in the Office of the Tamil Nadu Public Service Commission under compassionate grounds.

3. Application for appointment on compassionate grounds was preferred by Thiru.R.Ganesh on 23.11.2016 (i.e., within 3 years from the date of demise). On the date of application, he did not possess the required qualification of degree for appointment as Assistant in Tamil Nadu Public Service Commission. Thiru.R.Ganesh has passed Bachelor of Commerce in November 2018. His date of birth is 06.04.1991. He was appointed as Assistant in Tamil Nadu Public Service Commission on 12.09.2019. The appointment of the individual is as per the conditions laid down under Sections 15 and 20(6)(b) of the Tamil Nadu Government Servants(Conditions of Service) Act, 2016.

4. Further, Rule 7 of the Tamil Nadu Civil Services (Appointment on Compassionate Grounds) Rules, 2023 prescribes that the applicant shall possess the educational qualification for the post applied for, on the date of application. However, in this case, even though the individual did not possess degree on the date of application, he was in possession of the same on the date of his appointment.

5. In the above circumstances, after detailed examination, the Government have decided to regularize the services of Thiru.R.Ganesh, appointed under compassionate grounds in the post of Assistant in the office of the Tamil Nadu Public Service Commission with effect from 12.09.2019 (Date of Joining) by relaxing the rule 7 of the Tamil Nadu Civil Services (Appointment on Compassionate Grounds) Rules, 2023 in his favour in exercise of the powers vested with the Governor of Tamil Nadu under rule 17 of the said rules and orders accordingly.

6. Consequent on the orders issued in para 5 above, the individual is eligible for arrears of pay and allowances, if any, from the date of regularization.
