ORDER:

Thiru.P.Kadarkarai, while working as Process Server, Principal District Court, Tirunelveli died in harness on 27.11.2016. His son Thiru.K.Maharaja, has applied for the post of Junior Assistant in the Tamil Nadu Judicial Ministerial Service on Compassionate Ground. The date of birth of Thiru.K.Maharaja, is 23.02.1991. He has passed S.S.L.C., and H.S.C., He is thus eligible for appointment as Junior Assistant in the Tamil Nadu Judicial Ministerial Service. He was therefore appointed temporarily as Junior Assistant in the Additional District Munsif Court, Nanguneri and joined duty on the Forenoon of 16.08.2017. The Registrar (District Judiciary), High Court of Madras, has sent proposal for regularisation of the services of the above individual as Junior Assistant in the Tamil Nadu Judicial Ministerial Service with effect from 16.08.2017 F.N.

2. The Government after careful examination have decided to accept the proposal of the Registrar (District Judiciary) High Court of Madras, Chennai and verified all the original certificates of the individual regarding the appointment in the post of Junior Assistant on Compassionate Ground.

Accordingly, the Government direct that the services of Thiru.K.Maharaja, S/o. (Late) Thiru.P.Kadarkarai, Formerly Process Server, Principal District Court, Tirunelveli appointed on Compassionate Ground be regularised in the post of Junior Assistant under the Tamil Nadu Judicial Ministerial Service in the Additional District Munsif Court, Nanguneri with effect from 16.08.2017 F.N. subject to the condition that the individual should possess the physical fitness to hold the post in which he is regularized and ordered accordingly. In view of the retrospective regularisation, the individual is eligible to draw the annual increments and arrears of pay and allowances if any, as per the rules.


