**ORDER :-**

Under rule 10(a) (i) of the General Rules of the Tamil Nadu Ministerial Services Thiru.S.Naveen who has been provisionally selected by the Tamil Nadu Public Service Commission for appointment to the post of Junior Assistant included in the Group IV Services 2018-2019 and 2019-2020 vide the reference 1<sup>st</sup> cited and allotted to this Medical Department and re-allotted to the Directorate of Medical Education vide the reference 2<sup>nd</sup> and 3<sup>rd</sup> cited. He has been temporarily appointed as Junior Assistant at this Medical College and Hospital vide this office Appointment Order 4<sup>th</sup> cited and has joined duty as Junior Assistant on the **Forenoon of 11.09.2020** vide this office reference 5<sup>th</sup> cited.

The Tamil Nadu Public Service Commission in the letter 1<sup>st</sup> cited, has issued necessary concurrence for regularizing the services of the selected candidates. Accordingly, the temporary services of Thiru.S.Naveen, Formerly Junior Assistant, Government Medical College and Hospital, Omandurar Government Estate, Chennai is regularized in the post of Junior Assistant with effect from the date of joining i.e., on the forenoon of 11.09.2020, subject to the following conditions.

“The regularization is subject to the outcome of the WP's pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination IV for the year 2018-2019 and 2019-2020 recruitment”

He is placed on probation for a period of two years within the continuous period of three years from the date of regularization.

He should pass the following Departmental Test/Qualification and should complete the Foundational Training in Bhavanisagar within his Probationary period.
