2. All the above individuals are appointed as Junior Assistant **temporarily** in the revised pay matrix Level No.8 (Rs.19500-71900) corresponding to the pre-revised scale of pay Rs.5200-20200 + Grade Pay Rs.2400/- and other allowances admissible as per Rules.

3. All the above individuals are directed to join duty as Junior Assistant in the respective courts mentioned against each above on the **F.N of 03.10.2023** without fail.

4. They are also informed that no kind of representation regarding joining time will be entertained and if they fail to join duty within the specified time and the specified place, the Commission will be addressed for removal of his / her/ their name from the approved list.

5. They are further informed that the appointment is temporary and selection is made based on his / her / their claims made in their applications for the said recruitment and that if any of their claim is found to be false, his / her / their selection and appointment will be cancelled without any further notice.

6. The approved candidates thus appointed will be brought under the Contributory Pension Scheme.

7. They are required to submit physical fitness certificate to the concerned Presiding Officer of the Court, at the time of joining, which should be obtained from a Medical Officer of rank not lower than that of an Assistant Surgeon employed under the Tamil Nadu Government or by an Honorary Assistant Surgeon and Physician appointed by the Tamil Nadu Government to a Government Medical Institution.

8. Further, soon after joining duty, they are also required to submit their employment identity card without any delay to the concerned Presiding Officers. The respective Presiding Officers are required to submit the employment identity card, so surrendered, to the undersigned within seven days from the date of their joining duty.

9. Further, they are required to submit their return of assets and liabilities statement within three months from the date of their joining to duty, as per Rule 7 (3) of Tamil Nadu Government Servants' Conduct Rules, 1973.
