**ORDER:**

The candidates selected provisionally for appointment by Direct Recruitment to the post of Junior Assistant (Security)/Depot Manager Grade III in the Tamil Nadu Ministerial Service for the year 2015-16, 2016-17 and 2017-18 by the Tamil Nadu Public Service commission as per the list communicated in the reference (1) and (2) cited and mentioned in the Annexure to this proceedings, are provisionally appointed as **Junior Assistant (Security)/ Depot Manager Grade III** in the Tamil Nadu Ministerial Service with effect from the date of joining duty, in the level of pay of **Rs.19500-62000 (Level 8)** with allowances admissible as per rules in force.

2) The Sister Department Heads and District Joint Directors of Agriculture are requested to issue posting orders to the candidates allotted therein in the annexure to this order by registered post with acknowledgment due and with a copy marked to this office. The joining time may be allowed for 15 days from the date of receipt of the posting order.

3) Since, the selected candidates listed in the annexure were finally admitted by the Tamil Nadu Public Service Commission, their temporary services may be regularized from the date of their joining duty in the post of Junior Assistant (Security)/ Depot Manager Grade III except in Sl.No. 433, 434, 435 and 438 for want of genuine report for their community claim by the Chairman State Level Scrutiny Committee.

4) The seniority, Rotation and turn of the candidates shall be intimated separately on receipt of the same from the Commission.

5) The following paragraph shall be included in the regularization order of the candidate.

"The regularization is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination – IV for the year 2015-16, 2016-17 and 2017-18 recruitment".

6) The authorities concerned are requested to verify the certificates and photographs of the selected candidates at the time of joining duty.

7) As per the Tamil Nadu Government Servant (Conditions of Service) Act 2016 section 20 (5), the appointing authority are requested to ensure the candidates to produce the physical fitness at the time of joining duty. In respect of differently abled candidates the nature of disability, percentage of disability and their capacity to perform the duty shall be verified by the posting authority through District Medical Board.

8) The posting authority shall issue the posting orders immediately without any delay to the candidates.

9) The candidates shall not be entertained for any kind of representation regarding joining duty and if the candidates fail to join duty within the time specified by the posting authority, the name of such candidates list may be sent immediately to this office for removing such names from the approved candidates selection list. The posting orders should be sent to the candidates only by RPAD.

10) Since the appointment on provisional selection are made based on their claim made in their application for the said recruitment and that if any of their claim is found to be false, their selection and appointment shall be cancelled without any further notice.

11) The joining and not joined report of the candidates may be sent to this office in order to forward the same to the TNPSC.

12) The candidates listed below have been selected provisionally and conditionally subject to verification of their community claim. They are liable to be terminated from service and such penal and legal action including recovery of salary as a consequence, if State Level Scrutiny Committee as furnished the genuine report of the candidates community claim is found not genuine. On receipt of the genuine report, their services may be regularized.

13) The selected candidates mentioned in the Annexure and who join duty are directed to report whether they have registered their names with any Employment Exchange. if so, they should surrender their Employment Exchange identity Card, to their Head of Office / Controlling Offices concerned while joining duty, which will be sent to the concerned District Employment Office so that registration of the concerned candidates may be removed from the Live Register of Employment Exchange.

14) As per sub rule 3 of rule 7 in Tamil Nadu Government Employees Conduct Rules 1973, the candidate should furnish property statement within 3 months from the date of joining.
