ORDER:

Tmt.V.Muthulakshmi has been temporarily appointed as Junior Assistant under rule 10(a)(i) of General Rule for the Tamil Nadu State and Subordinate Services [Under section 17(1) Act 2006] vide reference 3rd cited and She is posted to the office of the Director of Medical and Rural Health services(ESI), Chennai vide reference 3rd cited. She had joined duty in the post of Junior Assistant on the Forenoon of 09.09.2020. She is fully qualified to hold the post.

The Tamilnadu Public Service Commission in letter reference 1st cited has issued necessary concurrence for regularisation of the services of the selected candidates. Accordingly the temporary Services of Tmt.V.Muthulakshmi, Junior Assistant, Government Hospital, Thiruparankundram is regularized in the post of Junior Assistant with effect from the date of joining duty in the post of Junior Assistant i.e. from 09.09.2020 Forenoon, subject to the following condition.

2. Foundational training in Civil services Training institute, Bhavanisagar.
