3) As per Adhoc Rules approved in the Government Order in the reference 7th cited, "every person appointed to the post in the Ministerial Service of this Directorate by direct recruitment shall, from the date on which she joins duty, be on probation for a total period of two years on duty within a continuous period of three years" and "every person appointed to the post of Steno Typist Gr.III by direct recruitment shall, within the period of probation, should pass the District Office Manual Test" (Now Tamilnadu Office Manual Test). As per G.O.Ms.No.130,P&AR(S)Department,dt.22.07.2008, the above Steno-Typists should also pass the certificate course in Computer on Office Automation conducted by the Technical Education Department, within the period of probation.
