They are placed on probation for a period of two years on duty within a continuous period of three years with effect from the date of regularisation in the post of Typist.

As per G.O.Ms.No.130 Personnel and Administrative Reforms (S) Department dt: 22/07/2008 & G.O. (Ms) No.43 P&AR(S) dt: 17/04/2009 he/she should possess a certificate course in computer on Office Automation conducted by the Technical Education Department or he/she should acquire such qualification within the period of probation. The probation will be declared only after getting a pass in the said Certificate Course and he/she shall not draw his/her subsequent periodical increment.
