ORDER:

Thiru.S.Mahesh while working as Senior Bailiff, Principal District Court, Namakkal died in harness on 18.8.2005. His wife Tmt.R.Sangeetha requested this office for appointment under compassionate grounds. The date of birth of Tmt.R.Sangeetha is 17.10.1976. She has passed Matriculation X-Standard, H.SC., B.Sc., M.Sc., and B.Ed., She is thus eligible for appointment of Junior Assistant in the Tamil Nadu Judicial Ministerial Service. She was therefore appointed temporarily as Junior Assistant in the District Munsif-cum-Judicial Magistrate Court, Paramathy and joined duty on the Fore Noon of 5.11.2015.

Based on the orders issued in the Government order under reference 1st cited above, the services of Tmt.R.Sangeetha, W/o.Late S.Mahesh, formerly Senior Bailiff, Principal District Court, Namakkal appointed on Compassionate grounds in the post of Junior Assistant under the Tamil Nadu Judicial Ministerial Service in the District Munsif-cum-Judicial Magistrate Court, Paramathy (now working at District Munsif Court, Paramathy) be regularized with effect from 5.11.2015 FN.
