ORDER:-

Tmt. B. Kumudhavalli, Typist, Greater Chennai Police, formerly Typist, Chief Office was initially appointed as Data Entry Operator in the office of the Superintendent of Police, Kancheepuram District under compassionate grounds. She reported for duty, as Data Entry Operator on 19.11.2012 FN.

2. Her service as Data Entry Operator has been regularized with effect from 19.11.2012 FN and her probation was declared with effect from 23.11.2014 A.N in the references 2nd and 3rd read above.

3. She was appointed as Typist vide reference 5th read above and posted to Chief Office. She has reported for duty on transfer of service in Chief Office, as Typist on 01.11.2019 FN.

4. As per Government Order 1st read above, the post of Typist may be regularized, as the post of Data Entry Operator comes under Tamil Nadu General Subordinate Service and the post of Typist comes under Tamil Nadu Ministerial Service.

5. Meanwhile, the regularization order was issued to her was cancelled in view of her appointment was done after 05.09.2018 for want of record of her service from Government.

6. Now, the Government have issued clear instructions in the reference 7th cited that, "it is not mandatory to send proposals for record of services of DEOs appointed through compassionate grounds to Government, where there is no relaxation required. The appointing authority himself can regularize the services of the individuals."

7. As there is no relaxation required in this case, the Government instructions have been taken into account.


8. Therefore, Tmt. B. Kumudhavalli, Typist, Greater Chennai Police, Chennai formerly Typist, Chief Office has fully satisfied all the terms and conditions relevant to the appointment on Compassionate Grounds. Hence it is hereby ordered that her services is regularized with effect from 01.11.2019 FN (i.e) from the date of appointment on transfer of service, as Typist.
