ORDER:

Consequent on appointment as Typist through compassionate ground, Thiru. J. Venkatesan, Typist was posted as typist in this Directorate and joined duty on the forenoon of 17.04.2017, vide reference first and second cited respectively.

His temporary services were regularized in the post of Typist with effect from 17.04.2017 FN vide reference third cited and placed under probation for two years within a continuous period of three years.


