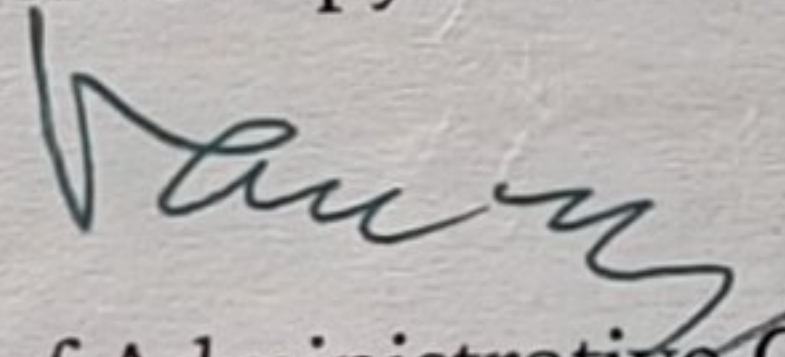
**ORDER:-**
