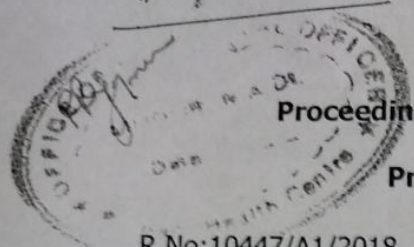


**ORDER:**


