The Government in G.O. 1<sup>st</sup> cited have issued orders and guidelines to be followed for facilitating speedy regularisation of service of employees who

were appointed on Compassionate ground during the period from 02.02.2016 to 31.12.2019 and said G.O. has been communicated to all the Appointing Authorities/Principal District Judges/District Judges/Unit Heads.

On scrutinizing the application of Thiru.D.Sivakumar, S/o.Late.P.Duraiswamy, (formerly Junior Assistant, Family Court, Dharmapuri, expired while in service on 08.10.2015), who has been appointed temporarily as Junior Assistant on compassionate grounds in the Principal District Court, Dharmapuri and all other relevant records, it is found that his case does not require any relaxation of rules and exemption of Government Orders.

The Principal District Judge, Dharmapuri, is hereby instructed to make necessary entries with regard to regularisation of the service of Thiru.D.Sivakumar, as ordered above in his Service Register.
