2. In the letter third and fourth read above, the Director of Town Panchayat has sent proposal for regularization of the services of Thiru.M.Ravikumar in the post of Junior Assistant with effect from 20.06.2018 F.N. the date on which the individual joined the services.

3. In the Government Order second read above, the Government has issued orders dispensing with the procedure of obtaining the concurrence of Tamil Nadu Public Service Commission for regularizing the services of the individual appointed under compassionate grounds.

4. The proposal of the Director of Town Panchayats fourth cited has been examined with all necessary certificates and documents and the Government hereby direct that the services of Thiru.M.Ravikumar appointed

under compassionate grounds as Junior Assistant in Thenkanikottai Town Panchayat with effect from 20.06.2018 F.N. be regularized as per Government Order fifth read above and order accordingly. The individual is eligible to get annual increments and arrears of pay, if any, as per the rules in force.

5) The Director of Town Panchayats is requested to make necessary entries in the Service Book of the individual as ordered in the para 4 above.
