ORDER:

Thiru.P.Sethuraman while working as Examiner, Chief Judicial Magistrate Court, Madurai died in harness on 19.02.2018. His son Thiru.S.Makesh applied for the post of Junior Assistant in the Tamil Nadu Judicial Ministerial Service on compassionate grounds. The date of birth of Thiru.S.Makesh is 23.02.1997. He has passed S.S.L.C. He is thus eligible for appointment as Junior Assistant in the Tamil Nadu Judicial Ministerial Service. He was therefore appointed temporarily as Junior Assistant in the Sub Court, Madurai and joined duty on the Forenoon of 05.07.2018. The Registrar (District Judiciary), High Court of Madras, has sent proposal for regularisation of the services of the above individual as Junior Assistant in the Tamil Nadu Judicial Ministerial Service with effect from 05.07.2018 F.N.
