The Government in G.O. 3rd cited have issued orders and guidelines to be followed for facilitating speedy regularisation of service of employees who were appointed on Compassionate ground during the period from 02.02.2016 to 31.12.2019 and said G.O. has been communicated to all the Appointing Authorities/Principal District Judges/District Judges/Unit Heads vide High Court's Official Memorandum 4th cited.

On scrutinizing the application of Thiru.M.Gokulraj, S/o. necessary entries with regard to regularisation of his service as ordered above in the Service Register of said Thiru.M.Gokulraj.
