She is informed that no kind of representation regarding joining time will be entertained and if she fails to join duty within the specified time and at the specified place, the commission will be addressed for removal of her name from the approved list of candidates selected to the post of Junior Assistant with reference to the Rule 23 of the Tamil Nadu Public Service Examination Rules of Procedure 2017. Failure to join duty may be reported to the commission for the removal of her name from the approved list with reference to the Rule 23 of the Tamil Nadu Public Service Examination Rules of Procedure 2017.
- 7. She is also informed that the appointment on provisional selection is made based on her claim made in her application for the said recruitment and that if any of her claim is found to be false, her selection and appointment will be cancelled without any further notice.
